

**RESOLUTION NO. 2007-011**

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOLANA BEACH, CALIFORNIA, RENAMING AND REDEFINING THE COMMUNITY/SCHOOL RELATIONS COMMITTEE AS THE SCHOOL RELATIONS STANDING COMMITTEE.**

**WHEREAS**, the City Council adopted Resolution No. 2005-146 establishing the Community/School Relations Standing Committee which is a City sponsored committee; and

**WHEREAS**, the reference to the 22<sup>nd</sup> Agricultural Association Community Relations Committee references a separate meeting prepared and noticed by this association and is therefore not City sponsored but instead a regional committee; and

**WHEREAS**, the 22<sup>nd</sup> Agricultural District Association Community Relations Committee will be placed on the Council's regional committee list as it meets separately and is responsible for its own noticing requirements; and

**WHEREAS**, the Community/School Relations Standing Committee would more appropriately be named the School Relations Committee; and

**WHEREAS**, the standing committees established hereunder shall have the membership listed herein and shall follow all required noticing as a permanent committee pursuant to the Ralph M. Brown Act.

**NOW, THEREFORE**, the City Council of the City of Solana Beach, California does hereby resolve as follows:

1. The City Council here by establishes the School Relations Standing Committee as follows:

a. Purpose: This Committee shall handle relations with the San Dieguito Union High School District, Solana Beach School District and private schools located within the Solana Beach boundaries.

b. Membership: Membership of the Committee shall include two Councilmembers.


c. Term: The term of this Committee shall continue until disbanded by the City Council. The status of the Committee shall be reviewed on an annual basis by the City Council.


